

BOBSLEIGH CANADA SKELETON (BCS) NATIONAL BOBSLEIGH PROGRAM (NBP) 2023-24 NBP ATHLETE FEE SCHEDULE (AFS)

In addition to agreeing to the terms of and signing the **2023-24 BCS Athlete Agreement** ("Athlete Agreement") and fulfilling any other requirements as may be notified from time to time, all Athletes who are selected to the **NBP** are assessed fees in accordance with the Athlete Agreement and this AFS.

1. NBP ATHLETE PROGRAM FEE (APGF)

The **NBP APGF** of **\$2,000** (two thousand dollars) is a fee assessed to support the ongoing operational activities of the NBP.

2. NBP ATHLETE INSURANCE FEE (AIF)

The **NBP AIF** is a variable fee, options outlined below, assessed to cover the costs of enrollment in the Canadian Athlete Insurance Program (CAIP). The CAIP schedule of benefits of each Level of insurance is outlined on the CAIP website [HERE](#).

2.1. In Canada Insurance – Accident Only at the Bronze Level*: **\$25 (twenty five dollars);**

**In Canada Insurance Upgrade Options:*

- *Upgrade Accident Only coverage to the Silver or Gold Level at an additional cost of \$25 or \$55 respectively; or*
- *Upgrade from In Canada Accident Only to Accident/Overuse coverage at the Bronze, Silver or Gold Level at an additional cost of \$210, \$440 or \$770 respectively.*

And

2.2. Outside Canada Insurance - Travel Medical Insurance at the level in accordance with each athlete's **Individual Performance/Progression Plan (IPP)**:**

- **\$210** (two hundred and ten dollars) for athletes traveling outside of Canada for a maximum of 30 consecutive days; or
- **\$350** (three hundred and fifty dollars) for athletes traveling outside of Canada for a maximum of 60 consecutive days; or
- **\$580** (five hundred and eighty dollars) for athletes traveling outside of Canada for a maximum of 90 consecutive days.

***Athletes can travel multiple times during the enrollment period as long as any one trip does not exceed 30, 60, 90 consecutive days.*

3. NBP ATHLETE PROJECT FEE (APJF)

Athletes identified as OTP Targeted Pilots, along with their respective crew, are assessed **NBP APJFs** in accordance with their respective **IPP**, to be communicated on an individual basis. The NBP APJFs are a direct contribution to the costs of a particular "Project" relating to the athlete's training and competition travel logistics of such Project which may include, but are not limited to, costs for flights, vehicle rentals, fuel, accommodation, meal plans, run fees and race entry fees.

Note: all other athletes, i.e. those NOT identified as OTP Targeted Pilots, along with their respective crew, are responsible for the costs of their training and competition travel logistics, in accordance with their respective IPP, and therefore are not assessed NBP APJFs.

4. AFS PAYMENT

4.1. The NBP APGF and NBP AIF are due upon nomination to the NBP and must be paid in full by the athlete to confirm their selection to the NBP.

4.2. NBP APJFs are due within 30 days of invoicing by BCS.

4.3. Fees may be paid by cash, e-Transfer, or credit card*** (Mastercard, Visa, AMEX) by contacting the BCS Finance Manager:

****Athletes who choose to pay their fees by credit card (Mastercard, VISA, AMEX) will be charged back the respective credit card processing surcharge.*

5. AFS TERMS

5.1. An Athlete who fails to pay the APGF, AIF and/or their assessed APJFs shall cease to be a "member in good standing" of BCS, with all associated consequences including but not limited to being ineligible:

- for the Sport Canada AAP;
- to participate in BCS National Team camps and/or events;
- to travel and compete in IBSF competitions; and/or
- receive other benefits from BCS.

5.2. All fees are non-refundable.

6. OTHER FEES

In accordance with the Athlete Agreement, BCS may, from time to time, assess other fees in relation to Athlete activities and programming.
